Instructions on how to enter form part of these Terms and Conditions. If there is any conflict between these Terms and Conditions and any other material then these Terms and Conditions will prevail. The promoter is SERVICE ONE Mutual Limited and its related entities ("We", "Us").

### **Eligibility:**
